# DRIVER FITNESS

## **SRT - Driver Fitness**

- **82% in July 2014**
- **51 violations**
  
- **38% currently**
- **29 violations**



# DRIVER FITNESS

## **Action Plan**

- Ensure DOT physicals make it to the state
- Set expirations 30 days in advance
- Immediate follow up and correction

# DRIVER FITNESS

## **Action Plan**

- \$50 for clean inspection
- \$50 charge for dirty inspection
- Look for a way to monitor drivers

# MVR MONITORING SERVICES

## **Additional Items**

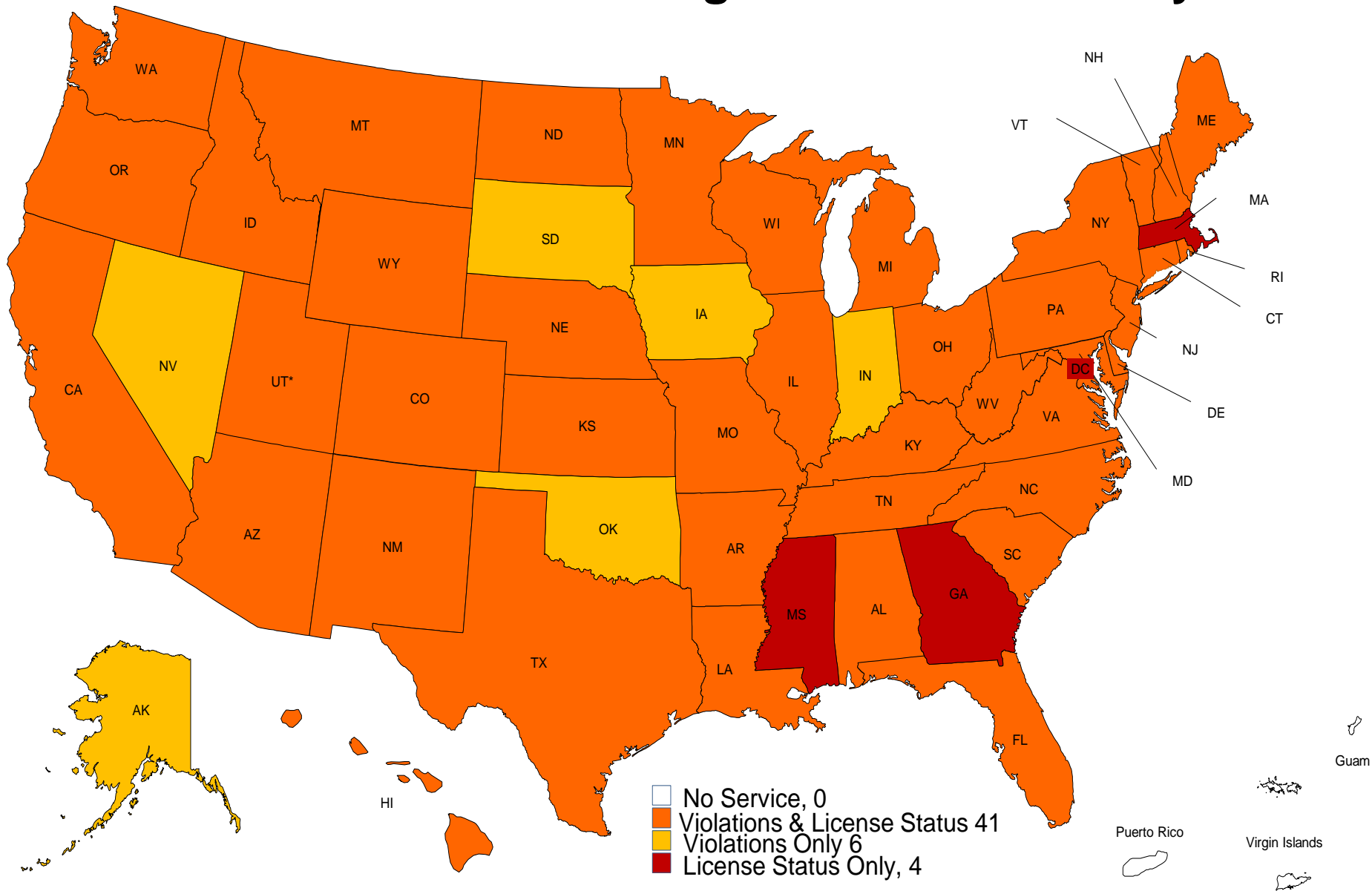
- MVR ran 15 days after physical – 391.51(7)ii
- After January 30, 2015 (was 2014), 15 days after DOT physical, must have the MVR with medical information ran and placed in DQ file

# MVR MONITORING SERVICES

## **Additional Items**

- Annual Reviews – 391.25
- Guidance – Question 4
- Third-party computerized system okay

## **Cost**

- Roughly \$1,700 to \$2,500 a month

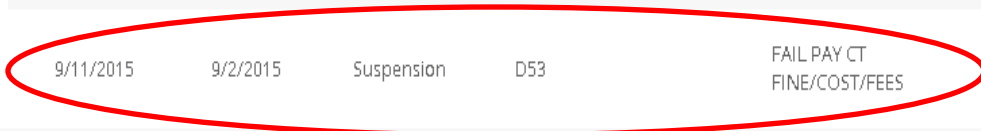

Report Name	Description
<b>Driver Import History</b>	Displays a list of driver file imports, associated statistics, and provides link to download import rejects.
<b>Driver MVR Schedules</b>	Displays summary of drivers' MVR schedules.
<b>File History</b>	Displays a list of files received for processing, associated statistics, and provides link to download rejects.
<b>General Statistics</b>	Displays various summaries of driver activity.
<b>Incident Summary</b>	Displays list of incidents with a count of drivers that have incurred that specific incident on their driving record
<b>Incident Summary By Type</b>	Displays list of incident types with a count of drivers that have incurred that specific incident on their driving record
<b>Medical Certificates Report</b>	Displays summary of drivers' medical certification.
<b>MVR Price Schedule</b>	Displays the price schedule for MVRs for each state
<b>Negative Incident</b>	Displays a list drivers and a count of the number of negative incidents on their driving record.
<b>State Characteristics</b>	Displays an interactive state map, with characteristics for the state selected
