**Presentation**

Sergeant Smith and Sergeant Gushing of the Arkansas Highway Police presented a PowerPoint presentation that entailed the 37 Steps of a Level I Inspection.

Q. Do you ask for the long form medical card from a driver?

A. Prefer card, but either will work as long as it has a date.

Q. Zip ties for airlines – violation for causing chafing?

A. Not in AR.

Q. What are five main triggers to pull a carrier over?

A. Obvious violations, not ISS.

Q. What is most common reason for OOS?

A. Brake components – pads and out of adjustment.

Q. Do you decide what level of inspection to do before starting?

A. Use own discrepancy, can change level of inspection at any time.

Q. Do you use ISS Score?

A. 90% of time we don't look at ISS score, some states do, could review ISS to see areas.

Q. Certain amount of inspections required?

A. Five a day is goal in our district.

Q. At what point is it considered an inspection?

A. Once logbook in in hand of motor carrier enforcement.

Q. What about electronic logs? Is everyone trained on enforcement side?

A. Like them. Some drivers need to be more educated on how to show hours.

Q. Citations for not being able to print logs?

A. Driver has to be able to show logs.

Q. Will you accept electronic file for medical card?

A. Yes.

Q. Most common electronic log violation?

A. Driver error – not knowing how to operate.
